Independent Auditors' Report

The Members of the School Board
Hanover County Public Schools:

We have audited the accompanying statement of cash receipts, disbursements, transfers, and balances arising from cash transactions of the Activity Funds of the Hanover County Public Schools (School Activity Funds) for the year ended June 30, 2016, and the related notes to the statement of cash receipts, disbursements, transfers, and balances.

Management's Responsibility for the Financial Statement

Management is responsible for the preparation and fair presentation of this financial statement in accordance with the cash basis of accounting described in Note 1; this includes determining that the cash basis of accounting is an acceptable basis for the preparation of the financial statement in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of the financial statement that is free from material misstatement, whether due to fraud or error.

Auditors' Responsibility

Our responsibility is to express an opinion on this financial statement based on our audit. We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditors' judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. Accordingly, we express no such opinion. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.



Opinion

In our opinion, the financial statement referred to above presents fairly, in all material respects, the cash receipts, disbursements, transfers and balances of the Activity Funds of the Hanover County Public Schools for the year ended June 30, 2016, in accordance with the cash basis of accounting described in Note 1.

Basis of Accounting

We draw attention to Note 1 of the financial statement, which describes the basis of accounting. The financial statement is prepared on the cash basis of accounting, which is a basis of accounting other than U.S. generally accepted accounting principles. Our opinion is not modified with respect to this matter.

Other Matter

Our audit was conducted for the purpose of forming an opinion on the financial statement as a whole. The supplementary information included on schedules 1 through 25 is presented for purposes of additional analysis and is not a required part of the financial statement. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statement. The information has been subjected to the auditing procedures applied in the audit of the financial statement and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statement or to the financial statement itself, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. In our opinion, the information is fairly stated in all material respects in relation to the financial statement as a whole.

Notes to Statement of Cash Receipts, Disbursements,

Year ended June 30, 2016

(1) Summary of Significant Accounting Policies

Nature of activities

The Activity Funds of Hanover County Public Schools (School Activity Funds) account for all class instructional fees and extracurricular activities monies collected by the schools. The money received into each school's activity funds must be spent in a way that benefits the students of that school.

Basis of accounting

The accompanying financial statement has been prepared on the cash basis of accounting, which is a basis of accounting other than U.S. generally accepted accounting principles. The only asset recognized is cash, and no liabilities are recognized. All transactions are recognized as either cash receipts, disbursements or transfers, and noncash transactions are not recognized. The cash basis of accounting differs from U.S. generally accepted accounting principles primarily because the effects of outstanding receivables and payables at the date of the financial statement are not included in the financial statement.

(2) Deposits

Cash held by the School Activity Funds is maintained in accounts collateralized in accordance with the Virginia Security for Public Deposits Act, Section 22 – 4400 of the Code of Virginia, or covered by federal depository insurance.

(3) Related-Party Transactions

During the year ended June 30, 2016, the School Activity Funds made combined payments of approximately \$2,279,634 to Hanover County, Hanover County Public Schools, and other schools within Hanover County for various services provided.
